04/15/01 <u>Circular</u>

The circular calling the meeting was held as read.

04/15/02 **Apologies for absence**

Apologies for absence were received from Mr A Carter, Ms G White, Mr W Spence, Mr A Henry, Mr D Ristori, Cllr J Wills, Cllr M Bell, Cllr A Wishart and Cllr M Stout.

04/15/03 Minutes

The minutes of the meeting were approved by Mrs A Simpson and seconded by Ms K Fraser.

04/15/04 Business Arising from the Minutes

Mrs Simpson asked about correspondence regarding signage for the Museum. She mentioned that during the Schools Music Festival endless numbers of people had been asking for directions to the Museum.

04/15/05 Police Scotland – Constable David Smith

Lerwick Community Council Draft Minutes – April 2015 Subject to approval at the May 2015 meeting

Constable Smith reported that the high detection rate for crime stood at 82.3%. Adverts had been placed for two support workers allowing the police station to open until midnight. Currently interviews were taking place and should result in these posts been filled. Two probationers were arriving in the coming weeks.

A road safety meeting was held in March regarding the issues outside Bell's Brae Primary School and was leading to progress. Unmarked cars up from south and been targeting inconsiderate and dangerous driving and figures for March were included in the report.

Working with Dogs against Drugs has led to 271 searches this year, with 123 taking place at either the ferry port or airport. Also educational visits speaking to school children have taken place. Six people have been charged with possession of controlled drugs. Operation Monarda focuses on the crime of bogus callers and leaflets are being handed out raising awareness.

Constable Smith informed members that contact with Police Scotland can be made using the number for Crime Stoppers or 101. He asked if there were any questions.

Mr Hay asked him to clarify the contact numbers.

Constable Smith replied that 101 was the non-emergency number. The Crime Stoppers was charity run and calls could be made anonymously.

Mr Anderson asked if he could skip forward before the Constable left, to a letter from Yvonne regarding a car wash at garages along the Ackrigarth Road and the speeding cars heading in and out.

Constable Smith said that this was obviously something to look into and he would take that back.

Mr Anderson thanked Constable Smith for his time and noted the excellent detection rate figures.

Constable David Smith left the meeting at 7.10pm.

04/15/06 Shetland Arts Development Agency – Graeme Howell, General Manager

Mr Anderson welcomed Mr Howell to the meeting and asked if anyone had any questions.

Mrs Simpson mentioned hearing from a member about the Garrison Theatre being starved of support.

Mr Anderson said that Mr Howell had been invited along to the meeting following concerns expressed and to inform the community council about future plans for the Garrison Theatre.

Mr Howell explained that they didn't own the theatre and it was not up to Shetland Arts. Shetland Arts ran it under contract from the Shetland Charitable Trust. The theatre generated income in three ways; conversations between the theatre and the

landlord, the other two, income from users and income from organisations generated around £50,000 per year.

They recently ran consultations around Shetland about the future of theatre in Shetland as they were keen to gather people's opinions. Five key area's identified were; people were looking for strong provision of youth theatre, well maintained space for amateur drama companies, subsidised use for Shetland drama groups, professionally led community productions and high profile touring productions.

Mr Howell said that when considering what this means further funding was a constant problem. The Garrison Theatre cost only £114.16 to hire for a day and Shetland Arts Development Trust had never increased this for years. They would be publishing new prices in the next two weeks. They didn't want to price amateur groups out.

They plan to put a strategy together and would like to come back to talk about it. There were a range of issues, such as long term structural issues. Investment in the building would be necessary over the next ten years. The theatre was one of the more heavily subsidised of all that Shetland Arts supported. They were committed to run it until March 2016.

In answer to questions Mr Howell said that the Garrison was the only proscenium arch theatre in Shetland, but there were many other places in the isles where theatre could be staged. Asked about attendance figures for Mareel, he said they suffered the same fall last year as everywhere. Films like *Skyfall* and *Hunger Games* had resulted in unbelievable high figures.

He said they were looking to develop 'events cinema' such as *The Crucible* and *Love's Labour's Lost*. Opera was an option, but there were contractual issues. They were completely driven by the product. Screening a particular film chosen from a list was another option for birthday parties.

Ms Garrick-Wright mentioned she had seen live streaming events and commented that it was good to see them been kept up.

Mr Howell said these were recorded live screen events and had provided successful. Events such as Wimbledon or anything that could be enjoyed in a group setting would be a good thing to explore.

Ms Garrick-Wright asked about broadcasting the Music Festival.

Mr Howell replied that it would be an interesting challenge. If the infrastructure was in place, it could work. He mentioned the need for improved broadband that was the frustrating problem in Shetland. He called Mareel an incredible facility. Currently 28 students were on their courses. Discussions on launching new courses were progressing. Also the first apprentice in technical theatre was to be taken on. This would help encourage young people to stay on the island. He said it was all positive, and felt very excited about it all.

Ms Garrick-Wright enquired about the challenges he was facing

Mr Howell said they were numerous. The main ones were the 'funding fairy' culture, the idea that there's a bottomless pit of money. Challenges such as customer care, value for the customer, and making them feel special.

Mr Hay said that Mareel was a great place for retired folk and a fantastic base for various events. He also thought it was acting well as the centre bringing together creative minds. He saw it as a real synergy of all the talents that are there, suggesting it could reshape education with creativity at the core and perhaps helping to sustain the future of the place.

Mr Howell agreed it was helping to enable people interested in creativity and it was not just about infrastructure.

Mr Anderson thanked Mr Howell and said he would be welcome back anytime.

Mr Howell left the meeting at 7.35pm.

8.1 Proposed Diversion of Staney Hill Rd (PROW) – Reply to LCC Response – Kevin Serginson

Mr Anderson asked if there were any comments or questions.

Ms Fraser pointed out that a gate could open and would not in any way be restricting the right of way. Something was necessary to stop livestock, presumably a barrier.

Mr Knight suggested that it shouldn't be open to vehicles, and they should bite the bullet, and make a proper walkway. He mentioned further housing in the future, and encouraging people to use it.

Ms Fraser agreed on the need to bring that forward. She said that until some years ago gates were in place and people used the gates. Cattle grids went in. Staney Hill had sheep and a grid and gate were needed.

Mr Hay commented that he walked their daily and the road was closed off to traffic. Digging was taking place along the old path, but the closure could be temporary. Street lights were being put up along the new path.

Mr Anderson agreed with Karen and would like to encourage folk to walk along.

Mr Fraser said that it didn't take much to get out and open a gate. She thought we should ask if they plan to do re-surfacing or leave as it was.

Mr Anderson suggested we write back and see what he says.

Mr Anderson commented that it was the more remote Fire Stations around Shetland looking to recruit. It was something he would flag up at the upcoming ASCC meeting.

8.5 Traffic Concerns South Road Roundabout up to Shurton Brae/Street Lights – Irvine Closs, Nicolson's Closs & Pilot Lane – Mr Dave Coupe – Executive Manager – Roads, SIC

Mr Anderson said that the information explained where they were at. Guidance had been issued about the sighting of crossings and the number of folk. Traffic count and speed analysis would show if there was a need.

8.6 Concerns at Ackrigarth - Yvonne Younger

Mr Anderson suggested that they forward the letter of concern onto Mr Kevin Serginson and see if there was anything that they can do about it.

Mrs Simpson mentioned that it was the responsibility, but not the requirement of the tenant. She thought that if it was overhanging, it could be cut and didn't need permission. She wondered who owed that bit of land.

Mr Anderson suggested they write and enquire about ownership and permission. (Action: Clerk to the council)

Mr Anderson agreed and mentioned that it was up to the members of the community council to come up with suggestions as funding was a standard item on the agenda.

Perhaps the first being, path improvements in Lerwick, which we could investigate and get prices for.

Mr Anderson informed members that the application had been completed for the armouring at the Sletts.

8.10 CDF Distribution & Project Applications – Micheal Duncan – External Funding Officer – SIC

Letters acknowledging CDF funding were noted. Mr Anderson mentioned the proposed slight change to the core funding. He asked if anyone had any questions.

Ms Garrick-Wright asked if Mr Anderson could give an example of how it would work.

Mr Anderson said that Lerwick Community Council Core Grant was £20,923.00. Three years ago £68,000 from total grant awarded to all community councils was removed from direct funding and used to establish the CDF project/distribution funds. All community councils can apply for distribution and project funding up to £3,000 and £1,000 respectively or £4,000 in total.

He said that community bodies could also apply, for the project funding, such as Living Lerwick, but require having the support of their local community council. A project currently in progress was the information boards, which they were hoping would be completed and installed soon.

04/15/09 Financial Reports

Mr Anderson highlighted the grants and projects and budgeted spending left for this year. He mentioned the lighting of the Clickimin Broch which was an on-going project for the Lerwick Community Council.

Discussion ensued about the expense of lighting the Broch by Lerwick Community Council. Use of LED lights and replacing lights with efficient models was suggested. This was seen as an option to explore and costs looked into.

10.1 Beervana – 133 Commercial Street, Lerwick – Stuart Fox, Shetland Beer Company Ltd

Mr Hay informed members that concerns had been raised by residents from 3 Reform Lane about duplication given that the Wine Shop was only fifty yards away and possibility of noise. He viewed that supply of speciality beers would perhaps make it different, but felt he had to inform about the views of the residents. He thought that

the street needed the footfall and whether it was over provision or not, he had no objections.

Mr Anderson mentioned the loss of JJ Henry's off-sale license to the street. He agreed it would attractive to tourists and helps promote Shetland Beer, along with the increased footfall to the street and having the building occupied.

Cllr Smith stated that it had not been before the licensing board and would be on the fourteenth of the month. There they would consider the over provision and anyone objecting would be welcome to come to the meeting.

Mr Anderson was happy to move no objections were noted.

Dear Chair

I am writing to let you know about a proposed Participatory Budgeting (PB) project, and to invite your Community Council to a presentation to find out more on Monday 27th April at:

- 3pm 5pm in Room 16, Islesburgh Community Centre; or
- 7pm 9pm in the Scalloway Public Hall, Berry Road, Scalloway.

If you haven't heard about PB before, it's an approach that allows local people to play a key role in deciding how public money is spent on projects and services in their area. It has been defined in simple terms, as 'local people having direct decision-making powers over part of a budget'. So it is more than consultation – it's a form of participatory democracy that can bring fresh perspectives.

PB originated in Brazil in the 1980s but has spread into Europe, the USA and beyond, with over 1500 initiatives reported worldwide. Hundreds of PB projects have been run in the UK in all types of communities, by local councils and in the public engagement work of police authorities, health boards, social housing, town and parish councils and within not-for-profit organisations.

"Democratic power should be delivered from communities up, not drip down from above. Democratic innovations such asparticipatory budgeting ... should ... become the standard by which [participation in decision making] is delivered in Scotland."

The Commission for Strengthening Local Democracy, 2014

In 2010 Shetland was one of five pilot projects across Scotland chosen by the Scottish Government and COSLA for its innovative proposals to use PB as a way of addressing community safety and anti-social behaviour. This kick-started PB in Shetland, with four PB projects delivered to date, providing a powerful way of engaging with local people, identifying local solutions to local issues, and building stronger communities.

Shetland Islands Council recently applied to the Scottish Government on behalf of the Shetland Partnership for support to develop our approach to PB in Shetland. Our application was approved, and the Scottish Government will be part-funding 10 days of support from PB Partners over the coming months. PB Partners are experts in the field of PB, and this is an exciting opportunity to benefit from their knowledge and experience.

The outline idea for the project is to develop and improve the Building Budgets community engagement approach which was first used last year. Running alongside this, there will be a pilot project to support Community Councils, on a voluntary basis, to use a PB approach to allocate their Community Development Fund to community groups in their area.

The proposed aims of the project are to:

- Provide opportunities for local people to have a say in what happens in their area
- Provide an effective link between local community and local democratic processes
- Provide an effective way to engage larger numbers of people in the work of Community Councils and increase interest in local issues
- Provide opportunities for communities to learn about local groups and organisations and increase interest in those groups
- Increase small scale funding to grass roots organisations and initiatives, including those that have not been previously funded
- Encourage active involvement in local decisions

The approach used for the project will be developed by two multi-agency project teams. The Community Development Fund PB pilot will include representatives from each Community Council involved, and meetings will be arranged to suit the needs of all project team members.

Following the introductory meetings on 27th April, expressions of interest will be sought from Community Councils to take part in the pilot, either individually or working together as an area grouping, with the aim of running up to three Community Council pilot projects this year.

Prioritised Future Road Improvement Schemes

Please find enclosed a prioritised list of the road improvement schemes that have, over the years, been requested throughout Shetland.

The list, which ranges from small low value works to large capital improvement schemes, currently numbers 119. In some cases the requests date back a number of years. The reasons they have not been progressed include lack of funding, lack of perceived benefit and other schemes taking precedence.

The Roads Service is often asked to provide updates on these schemes for which there is currently no funding under the Council's Medium Term Financial Plan. Therefore, it was deemed prudent to prioritise these schemes for such time as future funding may become available. The aim is to ensure that funding is targeted to achieve the best possible benefit for the road user and to provide a transparent system to better enable the Roads Service to answer requests from Community Councils or the general public.

The method of prioritising these schemes was approved by the Environment & Transport Committee at their meeting on 11 March 2014. The method scores each scheme according to corporate and technical criteria. The former assesses how well a scheme meets the aims of the Council's Single Outcome Agreement and Corporate Plan. The latter includes scores for cost, safety, roads hierarchy, a Roads Service ranking and a Community Council ranking.

We wrote to each Community Council on 3 June 2014 seeking their subjective score for the schemes in their area that were to be included on the prioritisation list. These scores were used to compile the master prioritised list that was approved by the Environment and Transport Committee, at their meeting on January 2015, and which is now enclosed for your information. The Committee also requested that a version of the list with cost bandings be

produced and distributed to Community Councils (see enclosure). This was considered necessary as there had been queries regarding the high placing in the rankings of certain schemes. These high placings were in some instances due to the low cost of the scheme which resulted in them gaining a high "cost" scoring. This meant that, for example, the provision of dropped kerbs for disabled and footpath gritter access was given a ranking of 2 due in part to its low estimated cost.

We did receive scores for a number of schemes that were not on the list that was sent out. The enclosed lists only contain the schemes that we knew of on 3 June 2014. The new schemes that we have been informed of since will be added to the list when it is next reviewed. This is to be done every two years.

I am lead to believe that the developer will be installing a cattle grid on the road where it enters the school site boundary though I don't know the exact details as it is being done as part of the overall construction of the new AHS and it's infrastructure. Presumably this has been agreed with the landowner/s. Unfortunately there are no plans that I am aware of to resurface the remainder of the Staney Hill Road above the location of the new path and diverted road, although I agree that this would be beneficial in term of walking and cycling links if funding were available. In regards to the vehicular use of Staney Hill Road as stated previously the public have rights to vehicular use and as such there should be no restriction unless a formal legal process (such as a Traffic Regulation Order) is gone through to restrict vehicular use. In my opinion the barrier should not have been installed without the formal process being followed. It is not just a question of agreements between landowners and tenants, but the removal or restriction of public rights which needs greater consideration and consultation. Whether locked or not a gate restricts the public's enjoyment of the route (otherwise there would be no point to it). If the landowners/tenants wanted to proceed with such an order they would need to contact the Roads Services to get further information. I hope this helps.
