PS G McCarthy asked the Clerk of the Council to correct the description 'automatic speed camera' to 'speed counter'.

**Club XL – Presentation Following Voluntary Work Undertaken in Cape Town**

Members of Club XL offered to give a presentation by way of thanks for the funding assistance granted to them by Lerwick Community Council.

Mr A Carter, Careers Adviser, provided some background on Club XL.

He stated Club XL was founded by the Prince's Trust and was a network of clubs running in schools all over the UK. It supports 14-16 year olds through their last two years of compulsory schooling and young people can choose to participate as an alternative to a Standard grade course.

Mr A Carter explained Club XL aimed to develop employability and the capacity to be employed, to nurture encourage and enable students to have the skills and attitude to make the best of their lives.

He stated 9% of school leavers had emotional and behavioral issues and had no positive destination on leaving school. Club XL worked on addressing this. He stressed XL focused on personal skills, citizenship and community awareness throughout the two year programme and the voluntary work in Cape Town was the culmination of that programme.

Mr M Davis, Student, Club XL fronted the presentation.

He stated following background work and research, the ten members of Club XL and their minders travelled to Cape Town to undertake voluntary work in an orphanage unit attached to the Eerste River Hospital.

He noted their remit was to create gardens, grow vegetables, erect a fence and work with the children of the orphanage.

Mr M Davis stated they dug up weeds, prepared the ground and sowed vegetables for the orphanage and community and planted a garden. They dug foundations mixed and laid concrete and built a fence using local trees.

He explained some of the older children from the orphanage helped with their work. Members of Club XL challenged them to a game of football and 'won on penalties'.

Time was also spent with the younger children from the orphanage, games were played and they were engaged with drawing and painting.

Mr M Davis stated they were the first group in eleven years to 'leave something behind'.

They had created a vegetable garden, built a fence left behind small play equipment for the children and painted and erected a sign for the orphanage.

Mr M Davis stated that while some of the male members of Club XL were hosted in quite luxurious surroundings the girls were not so lucky. Club members and locals alike worked together to make the girls' accommodation more clean and homely.

He stressed that they were made to feel very welcome by all the locals.

He explained Mr Price, a South African Muslim was their driver throughout their visit and he took them site seeing.

Their visits included a vineyard, Table Mountain and Robben Island where Nelson Mandela had been held prisoner for 22 years.

Mr M Davis explained it was a former prisoner who guided them round the now disused prison on Robben Island, he remarked on the dreadful conditions and tiny cells the prisoners were kept in.

The Chairman thanked Mr M Davis for 'one of the best power point presentations he had seen', and thanked Mr I McAlister, Mr R Gibson and Mr & Mrs Carter for attending the meeting.

### Police Report

PS G McCarthy provided the following details of offences compared to those of the same time last year.

He noted the details were for **April only**.

Crimes against the person – none reported  
Crimes involving indecency – none reported  
Crimes of dishonesty – down from 34 to 19, of which 16 were detected  
Crimes of vandalism – up from 17 to 25, of which 23 were detected  
Miscellaneous crimes – up from 49 to 64, with 63 detections  
Traffic Offences – down from 63 to 57, all detected

PS G McCarthy reported an overall detection rate of 91.4%, a 14.7% decrease in crimes compared to that of last year.

PS G McCarthy stated nine out of ten crimes had been detected and there were ten fewer victims of crimes compared to that of last year, a very positive result.

The Chairman asked what was the current position regarding CCTV.

Chief Inspector M Bell replied things were moving ahead with the project and it was hoped they would go into operation in early summer.

He stated it was another 'tool' in continuing to keep Lerwick safe.

Cllr J Wills reported he had received complaints from residents in Church Road and Chromate Lane regarding cars driving noisily up to the early hours of the morning.

He suggested the residents compile a log recording the problem and reminded them they could call the police at any hour.

PS G McCarthy noted he was aware of the situation and would be happy to receive the information.

He stated they hoped to purchase equipment which would record the noise levels coming from cars.

Mr L Angus thanked PS G McCarthy and Chief Inspector M Bell for the 'good news story' and all their hard work in reducing crime levels. He enquired how Shetland's crime levels compared to that of other areas.

Chief Inspector M Bell replied they compared favorably with an extremely low level of crime and high detection rate.

He stated the current detection rate was 91.4% and closest to this was 68%. He emphasised the figures were just for April, but that it was a good start to the year.

Chief Inspector M Bell reported he wanted to continue with 'bobbies' being more visible, noting it led to a downturn in crime.

He also stated the high level of detections could not be achieved without the valuable assistance of the public.

Ms K Fraser asked the Chief Inspector if the Police were catching the heroin dealers, were the Police getting on top of the problem and if any information came from the public.

Inspector M Bell replied 90% of the information received was intelligence based, coming from many sources. He stated £700,000 worth of heroin was removed from the street but Shetland was getting targeted from organisations from the North of England.

He stated the police force were being pro-active and were working on reducing demand. He explained the kids found drunk on the street today could be the heroin addicts of tomorrow.

The Chairman thanked PS G McCarthy and Chief Inspector M Bell for their report and all their hard work in reducing crime levels to such a degree.

PS G McCarthy and Chief Inspector M Bell left the meeting at 7.30pm.

**Mr Magnus Malcolmson, Leisure Facilities Officer, Shetland Islands Council – Update, Knab Dyke Reconstruction**

The Chairman welcomed Mr M Malcolmson to the meeting and apologised for keeping him waiting.

Mr M Malcolmson explained the Knab Dyke had been constructed over a century ago and had undergone numerous repairs over the years. He stated it had not been well constructed, particularly given the exposed area it was in. Weathering had taken its toll and vandals had removed exposed stones.

He stated new Health and Safety legislation meant wall close to the cliff edge could not be repaired but had to be rebuilt further away from the edge.

In 2003 a Condition Survey had been undertaken for the entire wall and the results were 450m from the Breiwick Road end was in such poor condition it had to be replaced and moved further away from the cliff edge. The report suggested the existing path should be used as an alignment and a new footpath developed as part of a rolling programme.

£50,000 was initially put towards the cost and in April 2004 the construction of the new footpath began. In April 2005 the second section of footpath was constructed and work on the dyke was due to commence in the spring of 2006. However, in March of that year a section of dyke collapsed and things had to back to the drawing board.

Mr M Malcolmson explained a Geological Survey took place round the entire perimeter from Breiwick Road to Twageos and the results identified 'pinch points', areas which may possibly collapse.

Plans had to change and an extra 150m of path added.

The Capital Projects Review Team rejected the first bid, this slowed the project down as the Review Team do not have regular meetings and it was months before the project could go out to tender.

Mr M Malcolmson stated the second bid, of £291,000 to replace the 450m collapsed section of dyke, by Shetland Amenity Trust, was successful and the final section of footpath was completed 2007-2008.

Work on the dyke itself began in March 2008, they hope to complete by late summer 2009. Shetland Amenity Trust are currently replacing the wall at a rate of 5m per day.

The dyke is being constructed on 100mm foundations using the majority of the original stone and a small amount of additional stone from the Shetland Islands Council, Staney Hill stock pile.

Mr M Malcolmson advised the lime mortar core and pointing gives the wall more strength and it looks good too.

Mr L Angus stated it was splendid to see things 'coming along at long last'. He pointed out the dyke below the cemetery at the south east corner needed tended to and asked what the plans were.

Mr M Malcolmson replied that would be part of another project and he would have to look into it.

Mr L Angus noted it was good to see such quality work being done.

The Chairman agreed it was all looking good. He asked Mr M Malcolmson if he had taken into account Lerwick Community Councils request for a viewpoint and seating area at the Knab.

Mr M Malcolmson stated that was also another project but agreed to discuss things once the Knab Dyke reconstruction was completed.

Mrs K Greaves enquired if the old footpath would be removed.

Mr M Malcolmson replied the footpath would be removed and landscaped.

The Chairman asked if things were any further forward in regarding the drainage problems on the footpath.

Mr M Malcolmson stated it would be incorporated in the rest of the works.

The Chairman thanked Mr M Malcolmson for his presentation.

The presentation concluded at 7.45pm.

Mr R Leith stated that Mrs L Simpson advised him that if the problem could not be rectified they may not be able to host the celebrations. Alternatively the price of the tickets to the Up Helly Aa night would have to be increased by £10 to fund purchase of new chairs.

Mr R Leith stressed it was the responsibility of Shetland Islands Council to supply the chairs.

Mr L Angus noted Sport & Leisures Services, Shetland Islands Council were looking into the issue.

The Chairman asked the Clerk of the Council to write to Mr M Malcolmson, Leisure Facilities Officer, Shetland Islands Council and ask for an update on the situation.
